I understand that bicycles, skateboards, baby joggers, roller skates or blades, animals and radio headsets are not allowed in the race and I will abide by this guideline. Having read this waiver and knowing these facts and in consideration of your accepting my entry,

As participant in the 5K Great Gainesville Road Race sponsored by SunState Federal Credit Union ("the Organization"), I am fully aware of the risks and hazards connected with my participation in the race ("Activity"), and hereby elect to voluntarily participate in teh Activity, knowing that the Activity may be hazardous to me or my property. I VOLUNTARILY ASSUME ALL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, that may be sustained by me, or any loss or damage to property owned by me, as a result of being engaged in the Activity, WHETHER CAUSED BY THE NEGLIGENCE OF THE ORGANIZATION OR ITS VOLUNTEERS, AGENTS or otherwise.

I Hereby RELEASE, WAIVE, DISCHARGE and COVENANT NOT TO SUE the Organization, the University of Florida Board of Trustees, the State of Florida, and their officers, servants, agents, employees, volunteers, Road Runners Club of America, the Florida Track Club, and all sponsors, their representatives and successors (hereinafter "RELEASEES")from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of our CAUSED BY THE NEGLIGENCE OF THE RELEASEES or otherwise, while particpating in the Activity. It is my express intent that this Release and Hold Harmless Agreement (hereinafter "Agreement") shall bind the members of my family, if I am alive, and my heirs, assigns and personal representatives, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE and COVENANT NOT TO SUE the above-named RELEASEES. I hereby further agree that this Agreement shall be construed in accordance with the laws of the State of Florida.
